## REQUIREMENTS

All speaker submissions submitted by 28 February 2023, and must include:

- Presentation title
- Speaker details: Name, qualifications, role, company, photo and short bio
- Abstract (300 words or less)
- Preferred format (presentation, panel discussion, debate, interview, workshop, panelist details, other)
- Description of how your proposed topic meets the conference theme
- Description of any novel or provocative information you will introduce
- Confirmation of whether the presentation has been used previously

If selected as a speaker, you should be:

- Willing to have photographs and video taken during the conference
- Able to support marketing and promotion of your presentation and #IAGR2023 through your network and social media (IAGR can assist)
- Willing to provide a short video describing your presentation
- Willing to develop a short (600 word) article for IAGR use to promote your presentation
