SPEAKER AND PANELIST REQUIREMENTS

All speaker and panelist submissions to be submitted by 29 February 2024 and must include the following:

- Presentation title (for individual speaker sessions)
- Your name, qualifications, role, company, photo and short bio
- Abstract (300 words or less)
- Preferred format (presentation, panel discussion, debate, interview, workshop, other)
- Description of how your proposed topic meets the conference theme – 'Navigate the future of gaming regulation in a transforming world'
- Description of any novel or provocative information you will introduce
- Confirmation of whether the presentation has been used previously

If selected as a speaker or panelist, you should be:

- Willing to have photographs and video taken during the conference
- Able to support marketing and promotion of your presentation and #IAGR2024 through your network and social media (IAGR can assist)
- Willing to provide a short video describing your presentation
- Willing to develop a short (600 word) article for IAGR use to promote your presentation

SPEAKER COMPENSATION

Non-member speakers will receive free registration for the conference and associated social events.

IAGR member speakers planning to attend the entire conference will need to register at the reduced member rate.

Accepted speakers need to meet own travel and accommodation costs.
