1. A title and abstract (300 words or less)
2. Your name, role, organisation and a short bio
3. Preferred format:
 - 20-minute presentation: Sharp, impactful insights
 - 40-minute presentation: In-depth exploration of complex ideas
 - 60-minute panel discussion: Please specify if you have other panelists in mind
4. An explanation of how your topic aligns with the conference theme: 'Resilient regulation: Exploring what works, why and what's next'
5. Confirmation of originality: Let us know if your presentation has been delivered elsewhere
